

How will DHL Group use my EcoVadis rating and assessment results?

DHL Group uses the results of the assessment, your scorecard, in many areas of procurement and business partner engagement, such as: New Supplier Qualification Criteria, integrated into "Supplier Relationship Management" (SRM), Annual Business Review Meetings and "Preferred Supplier" criteria.

What technical resources do I need?

No software installation is required: EcoVadis uses a web-based solution deployed on a secure platform that includes updates and technical support. All you need is an Internet connection and the documents requested in the guestionnaire phase.
